# 2 STRUCTURE, GOVERNANCE and MANGAGEMENT

The method of appointment of PCC members is set out in the Church Representative Rules. All church attendees are encouraged to register on the Electoral Roll and may stand for election to the PCC.

The aim of the PCC is to co-operate with the Rector in promoting in the Parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical.

The PCC met seven times in 2022 with an average attendance of 80%. Given its wide responsibilities the PCC has a number of committees each dealing with a particular aspect of parish life. These committees, which include the Social Committee, the Friends Committee and the Flower Group, are all responsible to the PCC.

The Standing Committee makes recommendations to the PCC and is authorized to conduct business if necessary.

The church has two part-time employees:

- Children and Youth People's Minister
- Parish Administrator (vacant from April 2022)

# 3 ELECTORAL ROLL and AVERAGE ATTENDANCE

The number on the Electoral Roll as at 31 December 2022 was 179 (157 in 2021)

Our average weekly Sunday attendance taken from the register for the month of October 2022 was:

❖ Adults 55 (16 years and over)

Children 16 (under 16 years of age)

In 2021 the average attendance was 60 and 12 respectively

# 4 OBJECTIVES and ACTIVITIES

The PCC have summarised their objectives with the strap line:

"To Know Christ and Make Him Known".

The PCC unanimously agreed to adopt the objectives of the 2026 Vision Statement of the Diocese of

- To make children, young people, schools and families their priority.
- To make disciples of Jesus Christ
- ❖ To be witnesses of Jesus Christ
- ❖ To grow leaders for Jesus Christ

All the deliberations of the PCC and subsequent decisions, activities and developments in church life in 2022 were made with these aims in mind.

# 5 ACHIEVEMENTS and PERFORMANCE

# 5.1 CHILDREN, SCHOOLS AND FAMILIES

**Children and Youth Work:** The PCC has continued to focus on the development of our children's and youth work as our top strategic priority. The Children and Youth Work can be split into three main groups each month:

- Sunday School
- Family Church
- Chat & Chocolate/Bible & Biscuits

Sunday School continues to be very popular with a usual attendance of 10-20 children aged 0-11.

We have split the children into 2 groups: under 7's and 8-11's with toys out for our very tiny children who tend to split their time between playing and joining in. The opening of the Lodge has made a huge difference to our Sunday School adding, about 10 minutes to each session and having a space to call our own, somewhere to store our equipment thus giving the children much more ownership of the group. Our group of volunteer leaders remain faithful in leading the groups and we couldn't run without them.

Family Church has continued to be very popular with families across the parish and beyond. Use of the Village Hall has given us a great space to run this service each month, with highlights of Pancake Church, Forest Church and Chocolate Church.

Chat & Chocolate is our young people's group for children too old for Sunday School. After confirmation in July, the young people asked us to add another group with more Christian input, so Bible & Biscuits was born in September. These groups aren't huge, but have a regular, committed group of young people coming each Thursday. Again, the use of the lodge has made a huge difference to these groups with more space and a more versatility for them to play games and move around.

# 5.1 CHILDREN, SCHOOLS AND FAMILIES (cont)

The Platinum Jubilee Lodge: The focus of our fundraising activities in 2022 was the building and opening of our Lodge which was essential to meeting our strategic aims especially for our work among children and young people and discipleship and outreach. The Lodge was completed in September 2022 and opened by Archdeacon Mark Ireland at a celebration service. There were 42 children in the Lodge on that occasion. The Lodge has, as hoped, transformed our children's and youth work.

The Lodge has already been as valuable as anticipated for the everyday life of the parish. It provides accommodation for PCC meetings and other committees and for social activities. It especially enhances the outreach and teaching ministry of the church enabling the provision of weekday meetings like the Alpha Course, Baptism preparation, Bible studies and soon a parent and toddler group to meet in comfortable surroundings.

**Schools:** We have continued to develop our partnership with our Church School. The Rector and Youth Minister lead worship weekly in school and now enjoy lunch once a week with the children. The Youth Minister has set up a Worship Group for some of the children to take part in leading Worship in school and contributing to school services in church. There have been regular services in church for Ash Wednesday, Ascension Day, Easter, Christmas, Harvest, the beginning and end of the school year. The Rector and Youth Minister have also led assemblies in our local non-church school and a church school further away, but with good links to our church.

# 5.2 MAKING DISCIPLES

The Lodge has made an Alpha Course possible in the autumn of 2022. About 20 people attended some or all of 7 sessions exploring together the excellent films on key aspects of the Christian faith like Prayer and Why Jesus died. This was attended by current members of the congregation and also some of the people seeking Baptism for their child.

- Baptism preparation was throughout 2022 an important way of developing links with young families
- ❖ 4 young people and 3 adults were prepared for Confirmation and Confirmed in a celebratory service led by Bishop Tony. Two of the confirmation candidates had been baptised in the few weeks prior to the service by full immersion in separate ceremonies.
- ❖ The two fortnightly House groups met in the first 7 months of 2022 and then members for the most part joined the Alpha course. These Bible studies/House groups are an important means of growing people's commitment to the Lord Jesus
- The same is true of our third inspirational Parish Quiet Day lead by Archdeacon Mark Ireland in November; this time in our new Lodge.
- ❖ In 2022 the bereavement group continued to meet and has proved to be an invaluable opportunity for a small group of those recently widowed to get to know others in a similar situation. It also provides a very valuable opportunity to deepen faith in the risen Jesus through participating in a Grief Share Course.

# 5.3 BEING WITNESSES

The church has continued to show love and care for the local community through support of the food bank. St Michael's has also continued to support global needs throughout the world eg: aid to Uganda and Ukraine plus charities like FOMO.

St Michael's also makes every effort to be a green church.

# 5.4 GROWING LEADERS

The members of the new Ministry team have developed their leadership gifts by preparing and delivering occasional sermons, leading Bible studies and Morning Prayer and taking on more pastoral work and Home Communions. The need for pastoral visiting in the parish has been increased by the opening of a new care home in our community – Ribble Court.

## 5.5 CHURCHWARDENS' and FABRIC REPORT

# **FABRIC OF THE CHURCH**

All routine safety checks have been completed in 2022, and general maintenance undertaken. There has been no major work required, but several areas have been monitored:

**Dampness and Decoration to the Internal Walls:** Some dampness has been noted behind the Memorial Book and across to the side of the altar. This area has been problematic before and needs to be monitored. The walls and ceiling around the altar area are starting to discolour again and redecoration may be needed at some point, although this is probably not urgent.

**Woodworm:** This has been noted in two of the pews near the back of church on the north side. It has been successfully treated and does not seem to have spread. An annual check will be undertaken and needs to include the tower and upstairs areas of church.

**The Boiler:** It has been operating without difficulty however, it is not getting any younger. We have already identified the potential need to replace the boiler in the next few years and for this we would need a faculty. Diocesan guidance is that all churches now require a green energy survey prior to application for a faculty to replace any boiler. This should be undertaken during 2023 as it remains valid for several years once completed.

**Electrical:** here have been several incidents in 2022 where the trip switches have been activated; leading to the church being suddenly plunged into darkness. The problem seems to lie with lighting around the stairs, but a full electrical check was needed as a matter of some urgency. (NB This has now been completed and problem resolved in January 2023).

**Drains:** Although there are some damp patches on the floors near the back of church at times, no specific problems with the drains have been identified and they appear to be flowing well. Downspouts are kept clear and water table monitored.

Internal Fixtures & Fittings: Nothing of note identified.

**External Brickwork and Roof:** Nothing of note identified.

Platinum Jubilee Lodge: The builders have addressed several minor "settling in" issues promptly and without additional charge. A need for a concrete path to link the central strip path in the car park across to the ramp access to the lodge has been identified, as those using a wheelchair or mobility aid cannot currently negotiate the gravel stones. Additional internal fixtures and fittings, as identified by the lodge users group, will be purchased when finances allow. Otherwise, no major expenditure is anticipated as this is a brand new building.

# 5.5 CHURCHWARDENS' and FABRIC REPORT (cont)

## **CHURCHYARD MAINTENANCE**

**Graves and Interred Ashes:** The PCC has now approved a recommendation that no further applications for grave space reservations will be accepted for our churchyard due to the growing shortage of available space. Any person who satisfies qualifying criteria will of course remain eligible for burial or interment of ashes without a reserved plot.

An ad hoc Churchyard Committee was formed in the early months of 2022, to consider updating our local information leaflet in line with the Diocese of Blackburn Churchyard Regulations 2014. Copies are clearly displayed in the porch. The revised leaflet was submitted to the PCC in May 2022 and subsequently approved. The leaflets were then made readily available in church.

# 5.5 CHURCHWARDENS' and FABRIC REPORT (cont)

On behalf of the PCC, the Wardens placed information around the churchyard advising those visiting graves to check that they were complying with updated churchyard regulations in terms of items that are permissible on graves and memorial plaques. We are now pro-active in removing seasonal tributes after an appropriate length of time (eg Christmas tributes removed by the start of lent). Monitoring will continue and many graves are already compliant.

Liaison with local funeral directors and stonemasons has also taken place regarding style and inscriptions of gravestones and plaques, and copies of the new leaflet left with them.

**General:** Mr Jock Davidson continues to take the lead on maintenance of the churchyard. A dead tree has been removed and general tidying undertaken during 2022. A "tip and tilt" has been conducted, and two gravestones had fallen onto their backs in December 2022. Boundary walls and fences appear sound.

# 5.6 DEANERY SYNOD

Three members of the PCC sit on the deanery synod. This provides the PCC with an important link between the parish and the wider structure of the Diocese.

# 5.7 SAFEGUARDING

As a Church we have adopted the House of Bishops 'Promoting a Safer Church' policy and the Parish Safeguarding Handbook, incorporating the House of Bishop's Safeguarding Policy and Practice Guidance. Our PCC has formally adopted this and signed the Safeguarding Policy Statement Promoting a Safer Church. Details of our Parish Safeguarding Officer can be found in the 'Contact Us' section on the website. We have also displayed the Promoting a Safer Church poster prominently within our Church. All those working with children and adults at risk have undergone safer recruitment, received safeguarding training and support.

#### 6 **FINANCE REVIEW**

#### 6.1 **CHURCH INVESTMENT and CURRENT ACCOUNTS**

**United Trust Bank 1 Year Bond:** This bond was closed in 2022 with a balance of £20,253.30. This money was then used towards the building costs of the lodge as designated by the PCC in their Parish Reserves Policy of 2021/2022.

**UTB 100 Day Notice Saving Account:** The balance on this account has been reduced to £5,559.38 and the money was used to ease the Church's cashflow shortfalls in 2022.

**HSBC Current Account Cashflow:** Cashflow continues to be a major problem as most of our resources, donations, and fund-raising have all been targeted towards the construction and fitting out of the Lodge. We believe that many of our donors and supporters may have diverted their donations in 2021/2022 from church to the lodge and this we understand and are very grateful for that support.

**Amalgamation of Church Funds:** In 2021 we reported we were amalgamating some church funds in order to reduce bank charges, streamline the accounting process and to comply with recommended charity practice.

- The Flower Fund is fully integrated.
- The Friends Fund amalgamation will be completed in 2023.

#### 6.2 **DONATIONS**

Donations to our Church are used to provide access to regular services, it growth, its outreach and its maintenance and they come from many sources and for difference reasons:

- Collections at all types of services (Sundays, Weddings, Funerals, Baptisms etc)
- Regular donations by individuals via the envelope system or standing order
- Special donations in memory of a loved one
- Specific donations for a particular fund or appeal

Sadly, we regret to report again that donations are still below pre-covid levels but now that the lodge is complete and almost kitted out, perhaps you could review your giving to Church for the year ahead. The good news is that giving in 2022 has increased by approx. £100 per month.

Gift Day - October 2022: This generated a range of promises, the majority of which have come to fruition. This has helped greatly with the improved average monthly giving and boosted the funding of some of our Restricted funds.

#### **RESTRICTED ACCOUNTS** 6.3

We have four Restricted Funds:

The Friends Fund The Flower Fund Youth Work

maintenance of the church, equipment, graveyard and all within its curtilage the beautiful decoration of our church for all types of services and festivals Platinum Jubilee Lodge the special appeal started in 2021 – construction complete, fittings ongoing started as a result of the Gift Day when donations were received specifically for this purpose in support the work of our youth minister and her team in their development of our young church, family church and Sunday school, incorporating mission and outreach

The finance team would like to give reassurance to all that our Restricted Funds, although amalgamated within the main church account, will continue to be used for the purpose(s) for which donations were given. This is a specific legal requirement that will be adhered to and monitored by the Trustees of the Church.

# 6.4 THE PARISH SHARE

The Parish Share for 2022 was £32,643.

This was met in full as we have endeavoured to do (and achieved) for many, many years. In the past, we have achieved this fairly easily but struggled in 2022 due to a reduction in income and increases in outlay. This resulted in the use of reserves and savings, not only that element designated for the Platinum Jubilee Lodge but also to pay essential running costs.

The Parish Share requested for 2023 was £37,183.

The treasurer, together with the Rector and Churchwardens asked the Diocese to review this assessment. We discovered that the share request was based on incorrect data; once the errors had been corrected, we were granted a significant reduction.

The Parish Share for 2023 was therefore reduced to £28,853.

The charitable giving from Church General Funds was approximately 7% of gross income. We usually aim for about 10% but we did not have the surplus cashflow to achieve this in 2022.

Our giving is reviewed annually, usually in March, therefore the recipients can change each year or during the course of the year as we respond to emergency situations.

It is hoped that in the coming year we can do better.

The Water Aid appeal, for the first time in over 10 years was not launched for the period Harvest 2021 to Easter 2022 as we did not have a volunteer to run it. However, a few "Jars of Change for Jars of Water" still trickled in and that money has been given to Water Aid.

## 6.7 THE CHURCH MAGAZINE

This is a non-profit-making endeavour; its primary aim is to inform and share the Christian worship and fellowship available at St Michael's Church. "To Know Christ and Make Him Known".

In 2022 the magazine made a loss of £568. This was greater than 2021 (loss of £55) because we had three full parish circulations for Easter, the Jubilee and Christmas. Without the Jubilee edition the magazine would have made a reasonable profit.

Grateful thanks go to the loyal support of our subscribers and advertisers and the dedicated production team, together with a great deal of invaluable work going on in the background. Every-one a volunteer.

The only outlay is printing costs.

Our long serving editor Honey Penrose retired in the Autumn having done a sterling job for more years than anyone can remember and we hope she enjoys her well-earned rest from this task.

The editorial task was gallantly taken on by Steve & Hilary Newman who produced the November & Christmas editions with new ideas and presentation.

# 6.8 THE PLATINUM JUBILEE LODGE – SPECIAL APPEAL

In 2021 planning permission and a faculty were granted for the construction of a new Lodge in the church grounds, now known as The Platinum Jubilee Lodge. Serious fund raising and grant applications were implemented throughout 2021 and 2022. The result was phenomenal.

On the next page is a summary of the financial status of that appeal, remembering that the initial quote and target was £70,000.00.

# 6.9 TEAM TREASURER

My thanks go to a team of people who consistently support me in my role as treasurer:

- especially Barbara Wood as Assistant Treasurer who also carries out the role of Gift Aid Recorder
- our banker Margaret Clark who diligently and conscientiously counts, records and banks the money every week having taken over from Mike & Elaine Lawrence in January 2022.
- our independent examiner, Adam Calvert of Rushtons Chartered Accountants, Preston who recently replaced Neil Calvert on his retirement. Rushtons have confirmed they are very kindly going to continue to provide their services free of charge.

### 6.10 LOOKING FORWARD

2022 was a challenging year in many ways but particularly with the amalgamation of church funds and the special appeal. At the time of writing this report we are nearing the end of the first quarter of 2023 and the good news is:

- Projected Gift Aid from all fund donations is expected to be £10,000 plus
- Regular donations appear to be slowly but steadily increasing
- Revenue from the hiring of the lodge should start in 2023

We will continue to do our best as trustees of the finances for your Church.

# What Can You Do?

Keep supporting your church in any way you can to help us reduce our running costs and increase our revenue by taking part in the fund raising and social events, offering your skills for all those jobs that need doing and last but not least, regularly review your giving.

# 7 RESERVES POLICY

- 1. It is the policy of this church to hold in reserve the equivalent of 3 months running costs as recommended in the Diocesan reserves guidelines. This includes church service costs, wages, rectory, and parish share.
- 2. It is expected that the church boiler and possibly the full heating system will need replacement and/or a full overhaul within the foreseeable future. Another consideration taken into account was the need to install Wi-fi if we can, to accommodate our growing young people's church. It was therefore felt prudent to set a reserve to cover these three items. It is anticipated that the funds held in our restricted accounts would be utilised for these purposes.
- 3. Our Church is a Grade 2\* listed building which requires responsible maintenance and repair. The next quinquennial in 2024 is not, at this time, expected to reveal any major works. In the meantime, minor repair work and running costs to keep the church in good order are ongoing which includes utilities, regular maintenance. servicing costs and the churchyard. The PCC has set aside a reserve from the restricted accounts to cover these regular annual costs.
- 4. A major outreach project is in progress as we seek to provide a base for:
  - our expanding work among children and young people
  - beginners' groups and our midweek Bible Study groups
  - community involvement e.g. Parent and Toddler group

It has therefore been decided to designate a reserve for the "Lodge Project."

The PCC believe we need to try and keep in reserve £73.5k from our joint church resources for 2021/2022. This is a significant increase from the £20k quoted in our year end accounts of 2020 for the reasons stated above. This leaves us with a reduced cashflow for 3 reasons:

- Income has not yet fully recovered since Covid
- Donations have not as yet returned to pre-covid levels
- Expansion & development activities for the growth of our Church
